## 2. COMPOSITION / INFORMATION ON INGREDIENTS

**Hazardous ingredients:** BISPHENOL A/F EPOXY 70-90%  
[Xi] R36/38; [Sens.] R43; [N] R51/53

## 3. HAZARDS IDENTIFICATION

**Main hazards:** Irritating to eyes and skin. May cause sensitisation by skin contact. Toxic to aquatic organisms, may cause long-term adverse effects in the aquatic environment.

## 4. FIRST AID MEASURES (SYMPTOMS)

**Skin contact:** There may be irritation and redness at the site of contact.

**Eye contact:** There may be irritation and redness. The eyes may water profusely.

**Ingestion:** There may be soreness and redness of the mouth and throat.

**Inhalation:** Exposure may cause coughing or wheezing.

## 4. FIRST AID MEASURES (ACTION)

**Skin contact:** Remove all contaminated clothes and footwear immediately unless stuck to skin. Wash immediately with plenty of soap and water. Consult a doctor.

**6. ACCIDENTAL RELEASE MEASURES**

**Personal precautions:** Do not attempt to take action without suitable protective clothing - see section 8 of SDS. Turn leaking containers leak-side up to prevent the escape of liquid.

**Environmental precautions:** Do not discharge into drains or rivers. Contain the spillage using bunding.

**Clean-up procedures:** Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method.

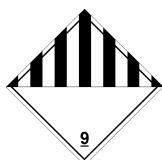
